

## 2016 Nominated Candidate Bios

With the new pricing method the club makes almost a 30% profit on all items while keeping the cost to members down. Using social media and our website also helped move items more quickly in spreading our brand.

Since 2014 I have been co-administrator on our FYC website and an admin on the Facebook page. I also served on the Membership Committee and Internet Committee in 2015 and volunteered for several other committees. I have a fair amount of experience leading volunteer organizations in the past. For the past 11 years I have served as president on the board of my condo association. Just recently I finished a major project on the complex of siding, trim and gutters, having put all the work out to bid and overseeing it on a daily basis. Next up, roofs and parking lots!

I am currently employed as a Senior IT Systems Engineer for a company in Fairfield that offers outsourced IT support for small to medium sized companies that don't have in-house IT staff. From 2002-2010, I took a side project and managed, and then owned, my own liquor store in the Norwalk area. I am very familiar with the CT liquor laws, and the profits and margins associated with that side of the business.
