### Special By Law Meeting to add to By-laws March 14, 7:45 pm prior to General Meeting Article XXIII Club Property and Dissolution

Section 1. All property of the Club, real and personal, now acquired or hereafter to be acquired, shall belong to and vest in the Club in its corporate capacity.

Section 2. The real estate, buildings, and appurtenances belonging to the Club shall not be sold except at a special meeting of the Club called for such purpose. Notice of such special meeting and a written proposal detailing the intended actions, shall be published in two issues of the Foghorn prior to such meeting, and sent to each member by a special mailing at least sixty (60) days prior to such meeting. Voting at such meeting shall be by paper ballot, and it shall require an eighty percent (80%) vote of the members present and voting at such special meeting to approve any proposed sale of Club property.

Section 3. The real estate, building, and appurtenances belonging to the Club shall not be leased, mortgaged or otherwise encumbered except at a special meeting of the Club called for such purpose. Notice of such special meeting and a written proposal detailing the intended actions shall be given to each member by mail at least ten (10) days prior to such meeting. It shall require a two-thirds (2/3) vote of the members present and voting at such special meeting to adopt any proposed lease, or encumbrance of Club proper-

Section 4. The Club corporation may only be dissolved at a special meeting of the Club called for such purpose. Notice of such special meeting and a written proposal detailing the intended actions shall be given to each member by mail at least ten (10) days prior to such meeting. I shall require a two-thirds vote of the members present and voting at such special meeting to adopt such dissolution. If the corporation is dissolved, and of the Club is no longer in existence in any form as a membership club to encourage and promote interest in yachting, and assets remaining after payments of all liabilities and obligations shall be distributed to such other nonprofit legal entities organized and operated to encourage and promote yachting as the Board of Governors may Choose.
