Dave Nemeth - Vice Comodore

It is an honor to be selected by the nominating committee to run from the Slate as Vice Commodore of FYC. I have been coming to FYC for almost thirty years. My Dad, George Nemeth, is a life member who joined the club in the mid-1980s. I personally joined FYC almost 7 years ago, because I wanted my growing family to have the same experiences that I had growing up. My wife, Kristie, is an Auxiliary member and you can usually find us all down on Sat. or Sun. with our son, Evan (nicknamed the Mayor,) and our extended families having lunch. I am a graduate of the Long Shore Sailing School in Westport, but do not currently own a boat, but I do have a kayak in the dink rack! In 2014, I served as Vice Commodore for FYC, where I met our goal of upgrading our draft system and expanding it from 4 to 6 taps. This offered us more of a variety of beer and increased the profits at the bar that year. Dan Conroy was a huge help in facilitating this for the club.

I have also worked to bring in high quality items at closeout prices in our Ship's Store. With the new pricing method the club makes almost a 30% profit on all items while keeping the cost to members down. Using social media and our website also helped move items more quickly in spreading our brand.

Since 2014 I have been co-administrator on our FYC website and an admin on the Facebook page. I also served on the Membership Committee in 2015 and 2016 and volunteered for several other committees. I have a fair amount of experience leading volunteer organizations in the past. For 11 years I was president on the board of my condo association and in 2015 finished a major project on the complex of siding, trim and gutters, having put all the work out to bid and overseeing it on a daily basis.

I am currently employed as a Senior IT Systems Engineer for a company in Trumbull that offers outsourced IT support for small to medium sized companies that don't have in-house IT staff. From 2002-2010, I took a side project and managed, and then owned, my own liquor store in the Norwalk area. I am very familiar with the CT liquor laws, and the profits and margins associated with that side of the business.
